## **About Sergei Galperin**



A native of Moscow, Russia, Sergei Galperin began violin studies at the age of five and shortly thereafter gave his first public performance in the Concert Hall of the Moscow Conservatory. After moving to the U.S., Sergei received his Bachelor and Master degrees from The Juilliard School, where he was a full scholarship student in the class of Dorothy DeLay and Hyo Kang. He made his American solo orchestral debut in May, 1982 at the age of 16, playing the Wieniawski Violin Concerto with the Symphony Orchestra of New York in Avery Fisher Hall at Lincoln Center. As a winner of Artist International auditions, Sergei made his New York solo recital debut in March of 1988 at the Weill Recital Hall at Carnegie Hall.

A first violinist of the Houston Symphony Orchestra since 1995, Sergei recently returned from the Orchestra's 2018 tour of Europe, which included concerts in Vienna, Hamburg, Warsaw, and Munich. In addition to being a performer and teacher, Sergei has access to the finest musical instruments and advises on the acquisition of violins, violas, and cellos to collectors, players and investors looking to diversify their portfolios in tangible assets. Musical instruments appreciate in value from 5 to 12 percent a year, need little maintenance, and have low insurance premiums. ### About the Cover Art

This magnificent *lira da braccio*, a 16<sup>th</sup> century precursor of the modern violin, is from the Collection of Historical Musical Instruments within the purview of the Kunsthistorisches Museum Vienna. It is remarkable to find such intricate decoration on a musical instrument, illustrating a man's face in the style of grotesque ornamentation popular at that time in Italy. Renaissance painters, such as Raphael and Pinturicchio, had themselves lowered by rope into the Roman "grottoes" or ruins of the Domus Aurea built for Emperor Nero, a legendary fiddler before the instrument was invented. They copied the frescoes on the walls, including complex patterns of vegetation as well as faces bearing bizarre expressions described as "grotesque." The artists included these elements in their masterworks such as the Villa Farnesina in Rome and the Church of Santa Maria Maggiore in Spello. So popular were these motifs that they found their way onto furniture, ceramics, and even musical instruments. From the lira da braccio, conceived as an instrument for street performers, the modern violin emerged as a concert instrument and the pride of virtuosi thanks to master craftsmen from northern Italy such as Andrea Amati, Antonio Stradivari, and Bartolomeo Giuseppe Antonio Guarneri.
